IMPORTANT INFORMATION

- **Minimum booking:** 2 days per week or 4 AM/PM sessions.
- **Opening Hours:** 7:30am to 6:30pm, Monday to Friday (excluding inset days and public holidays).
- **Session Times:**
 - Full day: 7:30am – 6:30pm
 - AM session: 7:30am – 1pm
 - PM session: 1pm – 6:30pm
 - School day session: 8:30am – 4pm
- **Fees:** Annualised over 52 weeks including absence periods.
- **Funding:** Annualised over 52 weeks.
- **FDC (Food, Drinks, and Consumables) Charge:** £2.20 is charged per funded hour. This covers meals, snacks, formula milk, nappies, creams, wipes, sun cream, and extra-curricular activities.

EARLY YEARS FUNDING EXPLAINED

Eligible parents in England can receive up to 30 funded childcare hours weekly during term time. KKDC offers this funding stretched evenly over 52 weeks, ensuring steady fees throughout the year.

Funding schemes (starting September 2025):

1. **9 months to 4 years** — for eligible working families
2. **Two-year-olds** — if the parent receives additional government support
3. **Universal funding** — for all 3- & 4-year-olds

What the funded hours mean

- **11 hours** means 15 hours of funding spread evenly across 52 weeks.
- **22 hours** means 30 hours of funding spread evenly across 52 weeks.

APPLYING FOR FUNDING

We encourage parents to apply for funded childcare as soon as possible to ensure you receive your eligibility code in time for the upcoming term.

- Not all parents get a code immediately — HMRC may require more info to check eligibility.
- A valid code must be issued before the 1st day of term.
- Eligibility must be reconfirmed every 3 months via HMRC's process.
- Once eligible, provide your child's Unique Reference Number (CURN) to KKDC through our online form to validate the code.
- If your child is 3 or 4 and not eligible for working parent funding, they qualify for universal funding from the term after their third birthday.
- Funding applies from the term after the child reaches the qualifying age.

ELIGIBILITY DATES

Child Born Between	Funded From
1st April – 31st August	1st September after birthday
1st September – 31st December	1st January after birthday
1st January – 31st March	1st April after birthday

FUNDED SESSIONS & FDC CHARGE

Free entitlement hours are spread over 52 weeks, up to a maximum of 11 or 22 hours weekly depending on your scheme. Funding applies up to 10 hours per day until weekly max is reached.

A **FDC charge** is applied per funded hour, covering food, drinks, and consumables. This is included in the monthly fee.

FUNDED ONLY SESSIONS

- Funded only sessions are available but capped and allocated on a first-come, first-served basis.
- Sessions run 51 weeks per year:
- **FDC charge is still applied** for funded only sessions as it is not covered by government funding. Parents can opt out but must provide all consumable items as per KKDC policy.

HOW WE CLAIM YOUR CHILD'S FUNDING

KKDC uses a digital platform to manage funding claims, providing a fast, secure way for parents and staff to submit required information.

- You will receive an email with a secure link to complete local authority declarations online.
- The platform offers step-by-step instructions, form validation, and easy uploading of birth certificates and proof of address.
- Calculations are automatic based on attendance, including children at multiple nurseries.
- The system meets strict IT and data security standards, independently tested by experts.
